At the request of the Fire Chief and on motion by Councilwoman Watkins, seconded by Councilwoman Hollowell with all members present voting AYE, City Council added "Emergency Purchase in the Fire Department" to the agenda.

The External Financial Consultant presented the Revenue report for the month of December, 2009.

NO OFFICIAL ACTION TAKEN

On motion by Councilman Gines, seconded by Councilman Simmons with all members present voting AYE, City Council approved minutes of a regular City Council meeting held January 5, 2010.

On motion by Councilwoman Hollowell, seconded by Councilwoman Watkins with all members present voting AYE, City Council approved minutes of a Joint Historic Preservation Commission meeting held January 12, 2010.

On substitute motion by Councilman Gines, seconded by Councilman Simmons with all members present voting AYE, City Council "received" minutes of a Joint Historic Preservation Commission meeting held January 12, 2010.

Mickey Watkins appeared before Council to discuss the Mental Health Parity and Addiction Equity Act and to present an Addendum which provides available options with regard to the administration of the City's Benefit Plan.

Mr. Watkins advised Council Federal legislation implemented January 1, 2010 removed the limits that were placed on Nervous/Mental and Substance Abuse coverage. Based on the new legislation, the Addendum will allow the employees to receive the same coverage for mental health & addiction treatment as any other illness. As a "Self-Funding Insurance" Agency, the City has the option to continue its coverage and accept the new policy provision or remove the coverage in its totality. Mr. Watkins further advised Council if the City opts to accept the new policy provision, there is potential for claims to increase approximately 20% (\$30,000-\$50,000) per year.

Following discussions, Councilman McGee made a motion to continue Nervous/Mental and Substance Abuse coverage and accept the Addendum to the City's current benefit plan. Councilman Gines seconded the motion.

Councilwoman Watkins made a substitute motion, seconded by Councilwoman Hollowell to maintain Nervous/Mental and Substance Abuse coverage as is until October, 2010.

ORDER # 10-030

ORDER: MAINTAINING BENEFIT COVERAGE AS IS WITH REGARD TO NERVOUSE/MENTAL AND SUBSTANCE ABUSE UNTIL OCTOBER, 2010.

On motion by Councilwoman Watkins, seconded by Councilwoman Hollowell with all members present voting AYE, City Council maintained benefit coverage as is with regard to Nervous/Mental and Substance Abuse until October, 2010.

Mickey Watkins representing Fred Salvo Associates presented Council with an update on the employee group health plan performance for the first year as a "Self-Funded" plan.

NO OFFICIAL ACTION TAKEN.

John Oglesby representing the Delta Conservation Demonstration Center (DCDC) appeared before Council regarding allowing Southern Rural Black Women's Initiative, Women in Ag the use of 23.15 acres of land rent free for a term of ten (10) years. Currently, the DCDC leases 616.5 acres of land from the City of Greenville and does not have the authority to allow partial use of their leased property for any purpose. Therefore, the Delta Conservation Demonstration Center request Council's consent to allow the Southern Rural Black Women's Initiative, Women in Ag partial use of the leased property.

Following discussions, Council granted permission to allow Southern Rural Black Women's Initiative, Women in Ag interest in the leased premises of Delta Conservation Demonstration Center.

ORDER: GRANTING DELTA CONSERVATION DEMONSTRATION CENTER AUTHORIZATION TO FURNISH 23.15 ACRES OF LAND LEASED FROM THE CITY OF GREENVILLE TO SOUTHERN RURAL BLACK WOMEN'S INITIATIVE, WOMEN IN AG RENT FREE FOR A TERM OF TEN YEARS COMMENCING JANUARY 1, 2010 AND EXPIRING DECEMBER 31, 2019.

On motion by Councilman McGee, seconded by Councilwoman Watkins with all members present voting AYE, City Council granted Delta Conservation Demonstration Center authorization to furnish 23.15 acres of land leased from the City of Greenville to Southern Rural Black Women's Initiative, Women in Ag rent free for a term of ten years commencing January 1, 2010 and expiring December 31, 2019.

ORDER # 10-032

ORDER: AUTHORIZING THE EXTERNAL FINANCIAL CONSULTANT TO BEGAN THE PROCESS OF OBTAINING PREVIOUSLY APPROVED TWO MILLION DOLLARS IN STREET BOND PROCEEDS.

On motion by Councilwoman Weathers, seconded by Councilwoman Hollowell with all members present voting AYE, City Council authorized the External Financial Consultant to began the process of obtaining the previously approved Two Million Dollars in Street Bonds proceeds.

The Airport Director request Council's permission to purchase a crew cab truck for the Airport needed to transport the inmates. Since the request was denied during budget session, the Airport informed Council the additional \$3,600 in funds needed to purchase the crew cab has been generated through various Airport funds. In addition he is also requesting the additional monies required for the purchase be transferred into the General Fund.

The Fire Chief advised Council the purifier at the main fire station went down and he is requesting permission to make an emergency purchase in the amount of \$23,176.48 to replace it. He stated the funds would come from the Fire Protection Fund.

Councilman McGee questioned the process used to reappoint Department Heads. He request the Human Resources Committee make recommendations regarding performance reviews that set clear, measurable objectives/expectations that each Department Head must achieve/meet. Councilman McGee also recommends that performance reviews are conducted on each Department Head on an annual or quarterly basis prior to Department Head reappointments.

Council was advised that Dr. Shannon's term does not expire until March 1, 2010. Council entered into discussions regarding the "process" that was being followed by not allowing interested persons the opportunity to submit an application and be heard. Council urged Councilman McGee to withdraw his nomination and encouraged him to be supportive of the community selection process.

Following discussions, Councilman Gines made a substitute motion seconded by Councilwoman Weathers to wait until the term expires to announce the School Board nomination with votes as follows:

On motion by Councilman Gines, seconded by Councilwoman Weathers with all members present voting AYE except Councilman McGee, Councilman Simmons and Councilwoman Watkins who voted NAY, City Council agreed to postpone appointment to the Greenville Public School Board until March 1, 2010.
